WITNESSETH:

WHEREAS, pursuant to Article XLV, the Declarant has the right to alter or amend the Declaration of the Villas of Lockwood Park Condominiums as recorded in Book 6997, Page 35, Cumberland County Registry; and

WHEREAS, Declarant desires to amend said Declaration of the Villas of Lockwood Park Condominiums as recorded in Book 6997, Page 35, Cumberland County Registry.

NOW THEREFORE, Developer does hereby amend said Declarations in pertinent part as follows:

1. Article XXV, the last sentence of Article XXV is deleted and the following is substituted therefor:

....."All doors, window frames, panes and screens, to include all screening on screened in porches, are a part of the respective Condominium Units and shall be maintained by the respective Unit Owners.

All dryer vents, water heaters and air conditioning drain lines shall be maintained by the respective Unit Owners. Each owner must cause an inspection to be made of dryer vents, water heaters and air conditioning unit drain lines annually. When necessary the Unit Owners shall cause any maintenance and/or repairs to be made. Proof of inspection and repairs shall be furnished to the Owners Association on an annual basis.
