of protecting the value and desirability of, and which shall run with the real property and be binding on all

parties having any right, title or interest in said property, or any part thereof, their heirs, successors and

assigns, and shall inure to the benefit of each owner thereof. By accepting a deed to any portion of the

Annexation Property, the owners thereof agree to abide by all of the covenants, conditions, easements and

restrictions contained in the Declaration, including the covenants to pay any assessments levied pursuant

thereto and to be subject to the liens for such assessments imposed therein.
