ATTACHMENT TO THE ARTICLES OF INCORPORATION Traemoor at Lakewood Homeowners Association, a North Carolina Non-Profit Corporation

ITEM #8: ADDITIONAL PROVISIONS TO BE INCLUDED

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to, its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles of incorporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal or state income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 and any successor section thereto, or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and any successor section thereto.
