AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF KAREN LAKE TOWNHOMES

Section 5. Section 5. <u>Insurance</u>. It shall be the duty of the Association to maintain in effect liability insurance as follows:

- Amount and Scope of Insurance. The Association shall obtain public liability insurance, as from time to time may be required by private institutional mortgage investors for projects similar in construction, location and use as the properties and the improvements thereon all under the terms and conditions as the responsible authority may determine. In any event, however, the Association shall procure liability coverage for an amount which shall adequately insure the Association against legal liability for property damage, bodily injuries, and death of person in connection with the operation, maintainance or use of the common areas. The Association shall obtain
- Premiums. All insurance policy premiums on the property for the benefit of the Association purchased by the Board of Directors are as designee, and any deductibles payable by the Association upon loss shall be a common expense and the Association shall levy against the owners equally as an additional annual assessment (herein called "insurance assessment"), which shall be in addition to the amounts provided for under Section 3 above, an amount sufficient to pay the annual cost of such liability insurance premiums. b.
- <u>Proceeds</u>. All insurance policies purchased pursuant to these provisions shall provide that all proceeds thereof shall be payable to the Board as Insurance Trustee, or to such Attorney at Law, or institution with trust powers as may be approved by the Board of Directors. c.
- Policies. All insurance policies purchased by the Board of Directors shall be with a company or companies permitted to do business in the State of North Carolina and holding a rating "A" or better by the current issue of Best Insurance Reports. All insurance policies shall be written for the benefit of the Board of Directors and the lot owners as their respective interest may appear; and đ.
