**SUPPLEMENT TO DECLARATION OF COVENANTS, CONDITIONS  
AND RESTRICTIONS FOR  
WOODLAND VILLAGE TOWNHOMES**

[To Memorialize a Recently Enacted Rule and Regulation of Association]

**THIS SUPPLEMENT TO DECLARATION OF COVENANTS,  
CONDITIONS AND RESTRICTIONS FOR WOODLAND VILLAGE  
TOWNHOMES** (this "Supplement") is made and entered into as of the date set forth in  
the below notary acknowledgment by **ELMWOOD PARTNERS, LLC**, a North  
Carolina limited liability company (the "Declarant").

**WITNESSETH:**

WHEREAS, the Declarant previously executed that certain Declaration of  
Covenants, Conditions and Restrictions for Woodland Village Townhomes recorded in  
Book 7767, Page 554, Cumberland County Registry (the "Declaration");

WHEREAS, the Declarant desires to execute this Supplement to memorialize for  
purposes of the public record a recently enacted "Rule and Regulation" of the  
Association.

NOW, THEREFORE, pursuant to Article III of the Declaration, as well as  
pursuant to authority contained elsewhere within the Declaration, and for and in  
consideration of the covenants herein contained and other good and valuable  
consideration, the receipt and sufficiency of which are hereby acknowledged, the  
Declarant (as the "Class B" Member of the Association) hereby states as follows:

1. The Declarant hereby memorializes the following "Rule and Regulation" of the the Townhome Development for purposes of the public record, said Rule and Regulation having been adopted by the Association pursuant to its rights under Section 3.3 of the Declaration:

"In order to provide for community safety, to provide protection for residents, children and families, and to provide for the stability of home values in Woodland Village Townhomes, it is hereby declared that no Unit shall be leased to, occupied by, or listed (in any law enforcement or public records) as the registered and/or domicile address of, a convicted, registered sex offender listed in any State or Federal sex offender registry. This Rule and Regulation shall be enforceable by any Unit Owner and/or the Association. A fine of the greater of \$100.00 per day or the maximum amount as permitted by the North Carolina Planned Community Act (N.C.Gen. Stat. 47F et seq) shall be imposed against a Unit Owner violating this rule and regulation. Any such fine shall be considered an additional assessment, shall be secured by a lien against the Unit in violation, and shall be subject to any and all rights and remedies of the Association as set forth in Article IV of (or elsewhere within) the Declaration. Any costs and/or legal expenses associated with the enforcement of this Rule and Regulation shall be paid by the Unit Owner who violates this provision. In addition, the Association shall have the authority to suspend all community privileges and services of the violating Unit Owner until the violation or any related monetary delinquency is cured. So as to afford sufficient due process and an opportunity to be heard for any Unit Owner alleged to be in violation of this Rule and Regulation, the procedures as set forth in N.C. Gen. Stat. 47F-3-107.1 (or, if revised, then any other pertinent future provision of the North Carolina Planned Community Act) shall be followed before any fine is imposed or any condominium privileges or services are suspended for a violation hereof. There is no obligation on the part of the Declarant to enforce this Rule and Regulation against any Unit Owner."

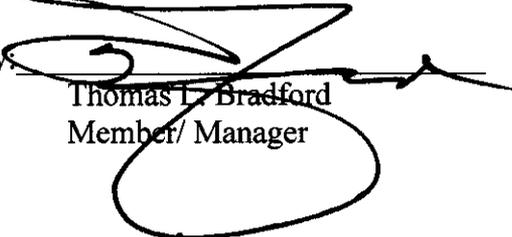
2. The purpose of this Supplement is strictly to memorialize the above-referenced enacted Rule and Regulation of the Association; and it is noted the Declaration remains unchanged and in full force and effect and the Declarant by its execution hereof, hereby ratifies, affirms and approves the Declaration. All capitalized terms that are not specifically defined herein shall have the meanings attributed to them in the Declaration.
