SUPPLEMENTAL DECLARATION TO DECLARATION OF LANDFALL CONDOMINIUM

CUMBERLAND COUNTY

LANDFALL PARTNERS, LLC, Declarant, hereby amends the Declaration of Condominium of LANDFALL CONDOMINIUM recorded in Book 6918, Page 423, Cumberland County Registry in accordance with Article XXVII, Section B, amending said Declaration as set out below:

- 1. Additional land is being added to the Condominium property and shall be known as Phase Four. The legal description for Phase Four is set out on Exhibit "A", attached hereto and incorporated herein by reference.
- 2. The units of Phase Four are set out on Exhibits "B", and "C" attached hereto and incorporated herein by reference.
