# SUPPLEMENTAL DECLARATION OF COVENANTS, CONDITIONS, EASEMENTS AND RESTRICTIONS FOR THE VILLAGE AT LEXINGTON SUBDIVISION

This Supplemental Declaration of Covenants, Conditions, Easements and Restrictions for The Village of Lexington Subdivision (the "Supplemental Declaration") is made this the 4 4 day of 5 vile, 2009 by Village of Lexington, LLC, a North Carolina limited liability company (the "Declarant").

#### <u>WITNESSETH</u>

WHEREAS, the Declarant is the Owner of record of certain real property in Harnett County, North Carolina known as The Village of Lexington Subdivision which is more particularly described in the Declaration described below (the "Property"); and

WHEREAS, the Declarant recorded a certain Declaration of Covenants, Conditions, Easements and Restrictions for The Village of Lexington Subdivision in Book 2426, Page 485, Harnett County Registry and as amended by First Amendment to Declaration of Covenants, Conditions, Easements and Restrictions for The Village of Lexington Subdivision Recorded in Book 2426, Page 485, Harnett County Registry as recorded in Book 2516, Page 863, Harnett County Registry (the "Declaration") for the development and maintenance of the Property; and

WHEREAS, the Declarant now desires to annex as additional property subject to the Declaration and First Amendment additional parcels or tracts of land located within The Village of Lexington Subdivision as shown on the plat recorded in Plat Book 2009, Pages 227-229,

Harnett County Registry, such property being more particularly described in <u>Exhibit A</u> (collectively, the "Additional Property"); and

NOW, THEREFORE, in consideration of the covenants and agreements contained in this Amendment and other good and valuable consideration, and intending to be legally bound, Declarant agrees as follows:

- 1. Pursuant to the authority in Article II, Section 5 of the Declaration, the Declarant hereby annexes the Additional Property into the Property and subjects it to the Declaration and First Amendment. Exhibit A attached hereto and incorporated herein by reference shall expand the Property subject to the Declaration and First Amendment to include the Additional Property.
- 2. This Supplemental Declaration shall be construed in accordance with the laws of the State of North Carolina. All capitalized terms not defined in this Supplemental Declaration shall have the meaning ascribed in the Declaration.
- 3. This Supplemental Declaration shall be binding upon and inure to the benefit of, and shall be enforceable by, each Owner, it heirs, successors and assigns in title to the Property or any portion thereof.


